Respective responsibilities of the body and the auditor

This smaller authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The smaller authority prepares an annual return in accordance with proper practices which:

- summarises the accounting records for the year ended 31 March 2016; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review the annual return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

External auditor report (ACKE0158)

Except for the matters reported below, on the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The Annual Return has not been approved in accordance with the Accounts and Audit Regulations 2015 as Section 2 was approved before Section 1 as shown by the respective minute references.

Other matters not affecting our opinion which we draw to the attention of the smaller authority:

The completed Annual Return and all relevant supporting information were not submitted for review by the date requested; the documentation was received one month late.

We note that the smaller authority did not comply with Regulation 15 of the Accounts and Audit Regulations 2015 as it failed to make proper provision during the year 2016/17 for the exercise of public rights, since the approval date was the same dates as the start of the period for the exercise of public rights (6 June 2016), the approval date must be prior to the approval date. As a result, the smaller authority must answer 'No' to Assertion 4 of the Annual Governance Statement for 2016/17 and ensure that it makes proper provision for the exercise of public rights during 2017/18.

The smaller authority has changed accounting basis in the year from a receipts and payments (R&P) basis to an income and expenditure (I&E) basis; however, Box 8 has also been restated. Box 8 should always be the reconciled bank balance excluding the effect of debtors and creditors existing at the year end. When presented on an R&P basis Box 7 will equal Box 8; however when on an I&E basis the debtors and creditors will represent reconciling items between the two amounts. Please refer to our instruction pack for completion of the 2016/17 Annual Return where we provide a pro-forma for the reconciliation between Boxes 7 & 8. Box 8 for the current year should therefore be £45,412. please ensure this is corrected in the 2016/17 Annual Return.
